PROCEDURE UTILIZED TO PACKAGE SAMPLES

On January 7, 2013, I shipped the processed coffee samples O, P, Q, R, S, T and U to the residue lab at Michigan State University in Lansing, Michigan. James Kam and I packaged the samples. We packaged the untreated samples O, R & T in one shipping box and the treated samples P, Q, S & U in another box.

I removed 7 sample bags from the University of Hawaii Laboratory freezer (RF-17) at 8:30 am. I placed samples O, R and T into one cooler. I placed samples P, Q, S and U into another cooler. Blue ice was added to each cooler to keep samples frozen. The coolers were transported in the bed of a pick-up truck to USDA-APHIS for inspection, and the samples were packaged there. The sample bags were packed in a styrofoam box with dry ice. A sample chain of custody form (Part 8B) and a sample arrival check sheet (Part 8C) were added to each box. The styrofoam box was taped shut and placed into a fitted cardboard box and sealed with tape. Two (2) boxes were packed in the following order:

Box #1 - Samples O, R & T with 35 kg dry ice.

Box #2 - Samples P, Q, S & U with 33 kg dry ice.

The sample boxes were taken to the Federal Express terminal and accepted for shipment at 10:00 am.
